AND

**KSHITIJ PESTICIDES, GONDUR DIST. DHULE, M.S** (Designated as PARTY B)

And Whereas it is the statutory object of the **Prof. Ravindra Nikam College Of Pharmacy, Gondur** to circulate an advance knowledge by providing guidance, training and extension facilities, in such branches of earning as it may deem fit and it shall try to provide students and teachers the required atmosphere and facilities for the advancement of:

- A. To expand the knowledge of students about toxicology
- B. Analysis of pesticides and food safety regarding traces of pesticides
- C. Development of students at multiple fronts

Now, Therefore The **PARTY A AND PARTY B**

Have agreed and consented to the following terms and deeds in achievement of a common intent to promote and develop the study of B. Pharmacy

OR

Make provisions for research and for the advancement and propagation of knowledge.

## **1. FIELD OF COOPERATION:**

- a. Both the institute and industry shall evolve a mutually acceptable schedule to develop programs, hold training, seminars and exchange visits.
- b. **The said academic institute interaction and intellectual assimilation may include.**
  - i. Students Training on handling HPLC and other analytical instruments.
  - ii. Organization of Seminars, research, conferences and workshops
  - iii. Analysis of pesticides and food safety regarding traces of pesticides

## **2. EXCHANGE OF STUDENTS/TRAINERS:**

- a. Mutual arrangements based on mutually acceptable terms shall be accomplished to give an motivation to collaborated activities of research, training etc. personels from both parties cheered to work together in the laboratories, workshops, faculties and departments of both the institutions.

- b. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated in this Para and shall vary according to the rules, regulations and policies of every institution.

### 3. MISCELLANEOUS:

- a. The details for the efficient execution of this MOU shall be jointly worked on all the terms within the parameters of the policies, rules and regulations of both parties.
- b. The parties can revise any term(s) and condition(s) of this agreement by mutual approvals.
- c. The MOU shall remain in force for a period of **07 years** from the date of its signature and seal, and may be terminated by either side by giving a six months notice in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- d. The parties to this **MOU** undertake to treat as **CONFIDENTIAL AND PRIVILEGED** information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- e. This MOU shall require the ratification of the competent academic/executive body of both the institutions.
