1. FIELD OF COOPERATION:

3. EXCHANGE OF LIBRARY RESOURCES SUCH AS BOOKS, ONLINE LITERATURE, JOURNALS ETC.




4. MISCELLANEOUS:

- a. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition(s) of this agreement.
- c. The MOU shall remain in force for a period of **05 years** from the date of its signature and seal, and may be terminated by either side by giving a six months notice to that effect in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- d. The parties to this **MOU** undertake to treat as **CONFIDENTIAL AND PRIVILEGED** information of the other institution, which is so classified in

advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

- e. This MOU shall require the ratification of the competent academic/executive body of both the institutions.
