- C. Development of students at multiple fronts

Now, Therefore The **PARTY A AND PARTY B**

Have agreed and consented to the following terms and deeds in achievement of a common intent to promote and develop the study of B. Pharmacy

1. FIELD OF COOPERATION:

 - v. Advice placements and execute training





2. EXCHANGE OF STUDENTS/TRAINERS:

- a. Mutual arrangements based on mutually acceptable terms shall be accomplished to give an motivation to collaborated activities of research, training etc. personels from both parties cheered to work together in the laboratories, workshops, faculties and departments of both the institutions.
- b. Issues relating to travel, boarding, lodging, miscellaneous expenses shall be incorporated in this Para and shall vary according to the rules, regulations and policies of every institution.

3. MISCELLLANEOUS:

- a. The details for the efficient execution of this MOU shall be jointly worked on all the terms within the parameters of the policies, rules and regulations of both parties.
- b. The parties can revise any term(s) and condition(s) of this agreement by mutual approvals.
- c. The MOU shall remain in force for a period of **05 years** from the date of its signature and seal, and may be terminated by either side by giving a six months notice in writing. However, notwithstanding the notice of the intent to terminate the memorandum, all rights, obligations and corresponding duties and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- d. The parties to this **MOU** undertake to treat as **CONFIDENTIAL AND PRIVILEDGED** information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- e. This MOU shall require the ratification of the competent academic/executive body of both the institutions.
